We have reminded the children about always demonstrating their polite manners, kind words and kind actions. We appreciate the support you give school to reinforce this expectation.

I began the week at De Stafford School hall with 18 year 5s and 6s! They were participating in a Sports Hall MultiSkills Athletic Event which involved speed racing, relays, obstacle races, long jump, chest jumps and javelin! This is an event we have not competed in before so I was so proud of the children's ability to look, listen and follow the instructions. We competed against five other schools and we were pleased we came joint fourth! The children's behaviour was impeccable and I was so proud of them.





On Tuesday, we welcomed some of our Trustees, our CEO, our Director of Finance and our Director of Education for a visit. I was so proud to show them around— the children were all working hard, offering to hold doors open without being prompted and modelling their 'proud walking' around the building— especially by Inkpen and Butterworth groups on their way to their phonics lessons.

On Wednesday, as part of their Sustainable CPFC Project, a group of Year 5 pupils

pitched to me a great idea to encourage traffic reduction days. They will be running a travel to school day on wheels (such as skateboards, scooters and bikes) in the Summer Term and designing the children a trail to ride on during sports week. What a great idea!

Next week is book week! Please do make a note of the daily events that are going on. We are all very excited about seeing Alice In Wonderland on Thursday as well as it being dress up day/PJ snuggle with a book option. I hope to see you next week at parent drop in on Tuesday afternoon at 2.15pm or at the Read with My Child event on Friday afternoon.

It was lovely welcoming the children back after half term and hearing all their news.

This week, we have launched our new topic of 'up in the air'. We created a topic-map from the children's current knowledge of what might go up in the air and we will revisit this at the end of the term.

The children have enjoyed a variety of arts and craft activities which have included making aeroplanes, kites and windsocks. We tested the windsocks with the children to see if they work outside. We also focused on our understanding of distance by using small aeroplanes on the playground. The children had great fun learning to see who could throw them the shortest and furthest distance. The children even got to experience a simulated helicopter ride as we converted our bubble cars into two helicopters in front of our white board.

We launched our talk for writing story 'Peely Wally' with a hook! The children discovered an unusual and very large bird nest in our flower bed which prompted lots of opportunities for discussion. The children have enjoyed learning some new actions for the story.

In phonics, we have focused on the letter 'U' through the 'what's in the box?' game and we have been developing our awareness of initial sounds and written name recognition. We have continued to enjoy pat-a-cake as our rhyme time song.

How Safe is WhatsApp for Children - NSPCC

NSPCC WhatsApp is one of the most popular instant messaging apps, used by over 2 billion people in 180 countries. It allows you to send and receive messages, as well as make voice and video calls. You can connect with people individually or join group chats where lots of people can contribute. All you need to set up a WhatsApp account is a phone number. However, children and young people can easily subvert the restrictions placed on its access. Although rated at 16+, all that is required is a phone number. All it takes is one child in a class to be on whatsapp, and all the others will wish to join. This can lead to increased vulnerabilities for child users. Please be reminded that children can only be collected by someone over the age **16**; unless we have been given written permission from a parent for those in Years 5 and 6 to leave without and adult.

After school activities

If your child is not going to be attending an after school activity but has been in school that day, please can you **inform the office** and not the class teacher. The office maintain the registers for all clubs and need to be aware of any child who is not going to be in attendance. Thank you for your co-operation.

Children should NOT be riding their scooters or bikes through the staff car park, down the driveway or through the playground at the beginning or end of the school day. Please ask the children to dismount and ensure you supervise your children whilst they are on them. Adults have reported some children are riding on the school grounds that is likely to cause an accident or damage to cars. Thank you for your co-operation.

PARKING & ROAD SAFETY

Once again, we have had some phonecalls from neighbouring properties regarding inconsiderate parking and unacceptable behaviour/language towards our neighbours at drop off and pick up times. **Please park considerately**



around the neighbouring properties to the school. According to the

Highway Code it is an offence to park across driveways and it is illegal to park over dropped kerbs. Parking on a private driveway without consent is a civil offence of trespass and may result in prosecution. A number of cars have been reported to the Police.

A number of parents have raised concerns regarding speeding traffic on Tithepit Shaw Lane at drop off and collection times. Please complete the road safety assessment form for Surrey to assess the road. We would recommend this is done as we return to school after half term to ensure they come when school is back in business. <u>Select the option</u> <u>most like the issue - Report a highway issue - Surrey County Council (surreycc.gov.uk)</u> - please select Road Safety Outside a School. Should anyone be interested, there is a vacancy for Road Crossing Patrol for outside the school. This is a paid vacancy through Surrey County Council.

Absences, medical appointments & sickness

If your child is absent from school or has a medical appointment, please email absence@hamseytlt.co.uk or leave a message on the absence line (01883 622000 option 1). Please let us know their full name, class and reason; including any symptoms they may be displaying. We do need to hear from an adult each day a child is absent for safeguarding reasons. Please do not bring your child to school if they have been sick during the night. If your child has been sick or has an upset stomach, children may be off school for 48 hours following the last episode, each case is dealt with separately.

Please try and book any medical/dental appointments outside of the school day.



If you consider that there are exceptional circumstances relating to your request, please let the school have full details. Each application for a leave of absence will be considered on a case by case basis.

Penalty Notices to Address Poor Attendance at School

A Penalty Notice may be issued as an alternative to the prosecution of a parent/carer for their child's unauthorised absence from school (absence without the agreement of the school or not covered by a medical note) and will be used by Surrey Council in the following circumstances :-

1. Pupils identified by police and Attendance Advice Officers (formerly Education Welfare Officers) engaged on Truancy Patrols and who have incurred unauthorised absences.

2. Leave of absence in term time (5 days or 10 sessions or more).

Please be aware that The Education (Pupil Registration)(England)(Amendment) Regulations 2013, which became law on 01 September 2013 state that Headteachers may not grant any leave of absence during term time unless there are exceptional circumstances.

The Headteacher is also required to determine the number of school days a child can be away from school if leave is granted.

In such cases the Headteacher/Governing Body must decide whether there are exceptional circumstances. They may request that Surrey County Council issue Penalty Notices when the absence is not authorised.

Warnings will not be given where it can be shown that parents have been notified that such absences will not be authorised.

3. Finally, the issuing of a Penalty Notice will also be considered where it is judged that a parent is failing to ensure their child's regular school attendance.

This will be considered when a pupil has incurred 10 or more unauthorised sessions in the previous 10 school weeks, which may include a pupil arriving late after close of registration.

If you believe at any stage that your child's absence from school may leave you liable to receive a Penalty Notice, it is extremely important that you act without delay to secure their regular attendance.

If you have any questions or require further support to achieve an improvement in your child's attendance, please contact your child's school or the Attendance Advice Officer.

Penalty Notice relating to Exclusions

If a child is excluded from school, Section 103 of the Education and Inspections Act 2006 places a duty on parents/ carers to ensure that their child is not in a public place without justifiable cause during school hours.

This duty applies to the *first five days of each exclusion*. Failure to do so will render the parent/carer liable to a Penalty Notice. (Alternative education provision will be made available from the sixth day of any exclusion.)

Amount Payable for a Penalty Notice and Consequences for repeat unauthorised absences

1. If you have not incurred a penalty notice relating to this child/children in a rolling 3 year period since 19 August 2024, then the penalty notice will be charged at the rate of £160.00, **per parent/carer per child**, if paid within 28 days. This will be reduced to £80.00 if paid within 21 days of receipt of the notice. Failure to pay the Penalty Notice will result in Surrey Council considering legal proceedings against you in the Magistrates Court.

2. If you have incurred a penalty notice relating to this child/children since 19 August 2024, the rolling 3 year period will be activated from the date of the first penalty notice and the second penalty notice will be charged at the flat rate of £160.00, **per parent/carer per child**, if paid within 28 days. There will be no reduction for payment within 21 days. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.

3. If you have incurred 2 penalty notices relating to this child/children in the rolling 3 year period since the first penalty notice was issued, then you will NOT receive a third penalty notice – Surrey County Council will have no option but to consider a prosecution, **per parent/carer per child**, in the Magistrates Court under s 444 Education Act 1996.

Surrey County Council is not responsible for authorising pupil absence and therefore cannot withdraw any Penalty Notice requests without the written permission of the Headteacher.
